**Events:** BS, GS, BD, GD, and MX in the following age categories:  
U-22 (Born in 1986 or later), U-19 (Born in 1989 or later), U-17 (Born in 1991 or later)  
U-15 (Born in 1993 or later), U-13 (Born in 1995 or later), U-11 (Born in 1997 or later)  
U-9 (Born in 1999 or later.) **Maximum of 3 events per player.**  
(Player's age must be under the age category as of 12/31/2007).

**Entry Deadline:** **November 8, 2007.** LATE ENTRIES WILL NOT BE ACCEPTED.

**Entry Fees:** \$30.00 per person for one event, \$35.00 per person for two events, or \$40.00 per person for three events. Make checks payable to USBDF. Group and College Student discounts may be available. **Entry fee waived for U-9 and International (non-US) players.**

**Eligibility:** The 2007 USBDF Winter Junior International Championships is open to all badminton junior players. US players must have USAB membership, can be purchased at the tournament.

**Awards:** Trophies will be awarded to U-9, U-11 and U-13 winners, runner-ups, and semi-finalists. Medals will be awarded to U-15, U-17, U-19, and U-22 winners, runner-up, and semifinalists.

## Conditions:

1. The tournament will be conducted in accordance with applicable BWF and USAB rules.
2. Events may be combined or played round robin format if not enough entries are received.
3. Consolation draws will be held for each event.
4. Up to two Yonex feather shuttlecocks per match will be provided free of charge.
5. All matches will be played in the best 2 of 3 games using the BWF Rally Point Scoring System. Consolation matches may be played in best of one game only.
6. A player not ready to play ten minutes after his/her match is called will be defaulted.
7. On court warm-ups is restricted to 5 minutes.
8. The 2007 US Junior's National results will be used for seeding arrangement. Past USBDF and USAB sanctioned tournaments results may also be used.
9. Each player in a doubles partnership must submit separate entry forms.
10. Entries will not be refunded if cancelled after November 8, 2007.
11. The Tournament Director reserves the right to change any of the above conditions.
