## Regulations:

1. A player can mix events from both categories Open or Open B provided that they are mutually exclusive. For example, a player can play Mens Singles in the **Open** and Mens Doubles in **Open B** but cannot play Singles in **both** the Open and Open B.
2. If a player is mixing categories then the entry fees of the Open category applies.
3. In order to participate in the B events, a player must **not** have reached "**A**" **Semifinal (men)** or "**A**" **Final (women)** in WSBA Closed, **Semifinals** in WSBA Open or any another ranking/sanctioned tournaments in the event which he/she wishes to participate, **subject to tournament director's discretion.**
4. Li Ning shuttles will be provided free of charge and used throughout.
5. Consolation draws will be held for each event.
6. All matches will be the best of three games to 21 points with rally-point scoring.
7. If there are more than 64 entries in any event, the tournament committee reserves the right to hold additional qualification rounds.
8. Prize money will total at least \$5000, which will be awarded to finalists of the Open events. Non-cash prizes will be issued to the finalists of the B events. The actual breakdown of the prize money will be provided onsite.
9. Please **register** 15 minutes before your first match.
10. A player not ready to play ten minutes after his / her match is called may be defaulted.
11. Acceptable badminton clothing must be worn during play.
12. Doubles partners are encouraged to wear matching colors.
13. Each player in a doubles partnership must submit separate entry forms.
14. Checks must be enclosed with entries and received by January 15th. No telephone, FAX or e-mail entries will be accepted.
15. If you don't have a doubles or mixed doubles partner, please put "Request" in the entry form and we will try to find you a suitable partner.
16. The tournament committee reserves the right to change any of the above conditions.

2. I knowingly and freely assume all such risk; both known and unknown, even if arising from the negligence of the releases of others;
3. I willingly agree to comply with the state and customary terms and conditions for participation. If, however, I observe any unusual or unnecessary hazard during my presence or participation or if I observe any concern in my readiness for participation, I will immediately bring such to the attention of the nearest official and refrain from participation; and

I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, hold harmless and promise not to sue Bellevue Badminton Club, the committee, their sponsors, their officers, volunteers, staff, sponsors and/or agents, ("releasees") with respect to any and all injury and loss arising from my participation, whether caused by the negligence of the releasees, the condition of the premises or otherwise, except that which is the result of gross negligence or wanton misconduct, to the fullest extent permitted by law.
